Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>Member without insurance may purchase health insurance against accidents in Bolivia, with coverage during training and competitions: (USD) \$ 25 per person</p>
VISA	<p>Please verify immediately with your travel agent or the Embassy or Consulate in your country if a visa is required for your travel to BOLIVIA.</p> <p>The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before October 4 to the Local Organizing Committee.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the delegation Member as well as the city, address and the mail address the visa application support letter must be sent to.</p>
