	· 2 D Judges, minimum 4 E Judges		
	The participating members Federations must send maximum 3 and minimum 2 qualified judges, with current valid FIG brevet if they participate with team in each level WAG – MAG, with individual gymnasts minimum 1 judge.		
	Failure to provide judges as mentioned above will result in an OC charge of U\$ 1000 to the federation concerned (non refundable).		
	This fine must be paid to the LOC upon arrival at accreditation desk.		
	The number of Apparatus Jury (judges' panel) will be decided by the organizing member federation depending on the number of participating competitors and judges. Not more than one judge per Federation per panel will be permitted (except for time and line judges)
