JUDGES AND JURIES	<p>The Apparatus Jury will be composed as follows:</p> <ul style="list-style-type: none"> · 2 D Judges, minimum 4 E Judges <p>The participating members Federations must send maximum 3 and minimum 2 qualified judges, with current valid FIG brevet if they participate with team in each level WAG – MAG, with individual gymnasts minimum 1 judge.</p> <p>Failure to provide judges as mentioned above will result in an OC charge of U\$ 1000.- to the federation concerned (non refundable).</p> <p>This fine must be paid to the LOC upon arrival at accreditation desk.</p> <p>The number of Apparatus Jury (judges´ panel) will be decided by the organizing member federation depending on the number of participating competitors and judges. Not more than one judge per Federation per panel will be permitted (except for time and line judges)</p> <p>The Apparatus Juries are set up by a draw from the judges present at the event. The draw will be conducted by the MAG and WAG Technical Delegates.</p> <p>The Organizing Member Federation is responsible to provide enough FIG brevet judges present with the appropriate valid category of brevet for their function.</p> <p>All judges must have a current valid FIG brevet.</p>

The tied gymnasts will all have the same rank, but subsequent ranks will be skipped:</p> <p>1,1,3,4,5,6,7,8 1,2,2,4,5,6,7,8 1,2,3,3,3,6,7,8</p> <p>The gymnasts will receive the same medal.</p>
