It is possible to participate with individual gymnasts, if a National Federation does not have a sufficient number of gymnasts for a full team.</p> <p>MAG competition Juniors (CI) A junior team consists of 3 – 5 gymnasts, of which 4 compete on each apparatus. The 3 best scores on each apparatus are added for the final result.</p>

The National Federation nominates the team for each apparatus.
It is possible to participate with individual gymnasts, if a National Federation does not have a sufficient number of gymnasts for a full team.

MAG competition Juniors (CII)
The 24 gymnasts with the highest ranking obtained in the qualifying competition CI will qualify for the all-around final CII.
A maximum of 2 gymnasts per National Federation are allowed in the finals.
For the all-around final, there will be 4 reserve gymnasts.

MAG competition Seniors and Juniors (CIII)
The 8 highest ranked gymnasts on each apparatus from CI will be qualified for the corresponding apparatus finals.
A maximum of 2 gymnasts per National Federation will be allowed in the finals. For the apparatus finals, there will be 3 reserve gymnasts per apparatus.

MAG competition Seniors (CIV)
The 8 best teams from CI will participate in the team final.
